The Court having found, upon reviewing the Declaration of Cameron R. Azari for Claims Administration and Distribution of Payments to Settlement Class Members filed pursuant to this Court’s June 3, 2020 Judgment Approving Class Action Settlement (Dkt. 115), that the Settlement Administration is substantially complete, and that the Claims Administrator has taken all appropriate steps to process all Claims, locate Authorized Claimants, and distribute funds pursuant to the Settlement Agreement;

1 It is HEREBY ORDERED, ADJUDGED, and DECREED as follows:

2 1. The Claims Administrator may proceed to close the Escrow Account  
3 established for the Settlement on or after July 31, 2021, the date upon which any  
4 outstanding checks for Basic Relief payments expire.

5 2. The Claims Administrator shall discontinue the Settlement call center  
6 and dedicated phone line on July 31, 2021. The Claims Administration process  
7 shall be deemed final and complete as of that date.


8 3. The Claims Administrator shall continue to maintain the Settlement  
9 website, [www.LapsedPolicySettlement.com](http://www.LapsedPolicySettlement.com) until December 31, 2021.

10 4. To the extent they have not already done so, counsel for Plaintiff shall  
11 confirm that all confidential information and records produced by Defendants  
12 pursuant to the Protective Order have been returned to Defendants.

13 5. As set forth in this Court’s Order dated June 3, 2020 (Dkt. 115), the  
14 Court reserves exclusive jurisdiction as to all matters related to administration,  
15 consummation, enforcement, and interpretation of the Settlement Agreement and  
16 this Order.

17 IT IS SO ORDERED.
